A Message From the Chief Administrator



Achieve. Lead. Soar

These three words make up the tagline approved by the Holy Family Board of Education during the 2013-2014 school year. They further reinforce our new mission statement, *Forming disciples of Jesus Christ through Catholic educational excellence*, and set the tone for all we do at Holy Family.

ACHIEVE: For three years we've worked toward the goal of becoming the top academic system in the state of Iowa, and you will see in the pages of this magazine that student achievement continues to support that goal. On multiple measures, including Iowa Assessments (formerly Iowa Tests of Basic Skills/Iowa Tests of Educational Development) and Measures of Academic Progress (MAP), we see impressive results, especially in math. With strong curriculum in all core subjects, electives such as pre-engineering and Chinese language classes, activities such as robotics and computer programming at every level, and teachers who are driven to provide students the best education possible, it's no wonder students *achieve* at such high levels.

LEAD: At Holy Family, we have high expectations for student involvement and behavior. Beginning in our Pre-K and kindergarten classrooms, students have multiple opportunities to develop their leadership talents, with many of those opportunities available through the celebration of our Catholic faith. Students lead the singing at or plan school Masses, lead the before-school rosary at Wahlert Catholic and plan and carry out service projects. A full slate of athletic and fine arts programming across the system further reinforces the development of leadership skills. How do we know that our efforts in developing leaders are effective? One important measure, the Dubuque Area Youth Leadership Council (DAYLC), shows that a higher percentage of Wahlert Catholic seniors are chosen for membership and honors than any other school in the tri-state area.

SOAR: The word SOAR tells the true tale of the value of a Holy Family education. Our students soar by donating more than 30,000 hours to serve their parishes and the Dubuque community. If you walk the halls or attend a Mass at a Holy Family school, you'll see polite, respectful and faith-filled students who understand the difference between right and wrong and are focused on learning. Academic and co-curricular programming ensures our students are critical thinkers, creative problem solvers and effective communicators—skills positioning them well for a future beyond our imagination. And, it seems that on a daily basis, we learn of another graduate who is making a difference in his or her college, career, parish or community. Students and alumni who *soar* to incredible heights are our greatest success story.

Enjoy more details of that success story on the next several pages. Read, too, about the School Tuition Organization program that is absolutely crucial to our ability to educate students whose parents cannot afford the cost of tuition. We want all students to be able to *Achieve. Lead. Soar*

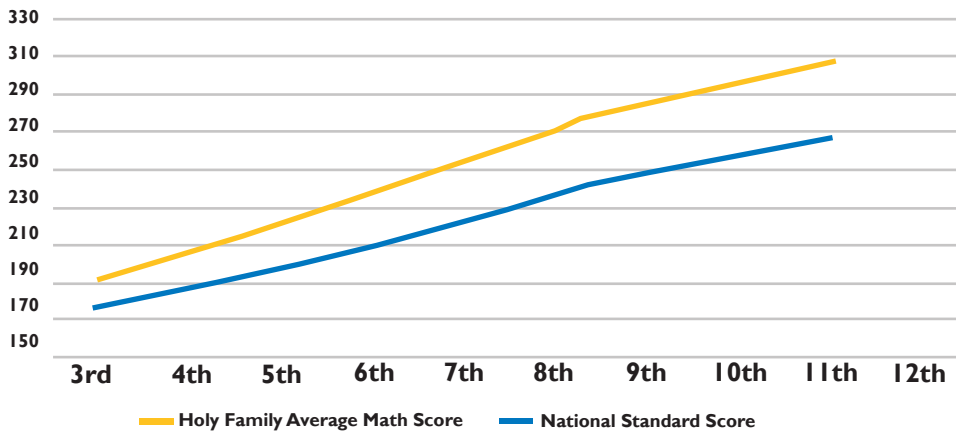


How We Measure Our Success

Three Recognized by National Merit

Wahlert Catholic High School students **Joshua Jackson**, **Jennifer Dietzel** and **Aaron Gonner** were selected as Commended Students in the 2014 National Merit Scholarship Program.

Spanish Immersion Competency Results

As a result of completing our Spanish Immersion program, 24 Wahlert Catholic students took the Spanish Immersion Competency Results test. Seven earned four years of Spanish high school credit, eight earned three years and nine earned two years.

Wahlert Catholic Named to 2013 Iowa AP Index Top 10

Wahlert Catholic High School was again recognized as an Iowa AP Top 10 school, making it one of the best schools in the state for Advanced Placement opportunities. The AP Index measures the average number of AP exams taken by members of the graduating class.

DAYLC Recognition

Three Wahlert seniors were recognized by the Dubuque Area Youth Leadership Council. **Jennifer Dietzel** and **Anne Lehmann** received first and second

place honors, while **Lauren Noel** was named in the top ten. Wahlert Catholic represented the Dubuque-area with 17 out of 100 students nominated by the DAYLC committee.

Wahlert Catholic Receives Sportmanship Awards

Wahlert Catholic earned both the Winter and Spring/Summer Sportsmanship awards from the Mississippi Valley Conference. Game officials rated players, coaches and fans from all schools to determine the top school in the league for these honors.

Academic Camps

More than 600 Dubuque preschool, elementary and middle school students attended a summer camp at Holy Family Catholic Schools. With an increased focus on academic camps, specifically STEM camps that focused on robotics, math and engineering, students as young as kindergarten built problem-solving skills. The Wahlert athletic department held camps and league play for future Eagles athletes.

Eighth Grade Recognition

On May 29, 2014, 118 members of the Mazzuchelli Catholic Middle School eighth grade class were honored.

Graduation

On Sunday, May 25, 2014, 128 members of the Wahlert Catholic High School Class of 2014 participated in the baccalaureate Mass and graduation. One hundred percent of the class graduated.

Service Recognition

Holy Family students serve the Dubuque community more than 30,000 hours each year. Twenty-five seniors earned the Servant Cord for contributing more than 150 hours of service to the community over the last three years.



How Can You Help?

Are you an Iowa resident? Would you like to **direct your tax dollars** to help students attend Holy Family Catholic Schools at little or no cost to you? If you answered yes to both of these questions, we ask that you consider a gift to the Our Faith, Our Children, Our Future School Tuition Organization (STO).

The STO program is of huge benefit to Holy Family, as parents whose income is at or below three times the poverty level qualify for assistance and are able to choose a Catholic education for their children. **Our families receive almost \$1 million each year** to offset the cost of tuition.

There is huge benefit to donors to the STO as well, as the program offers a 65 percent Iowa tax credit plus full federal

deductibility. The higher your tax bracket, the lower your actual cost for your STO contribution, but anyone who has an Iowa tax liability will benefit from this program. In the eight years that this program has been in existence, many people have reported they have actually **made money by contributing**. In essence, you can make your charitable contribution budget go almost **twice as far** because it costs so little to contribute.

Time is of the essence for this program. Contributions must be received by December 31 and there is a limit to the tax credits available. Our goal is to match the STO money restricted to Holy Family to the calculated financial need of our families. Can you help us reach that goal? Find out more about the STO at www.ourfaithsto.org.

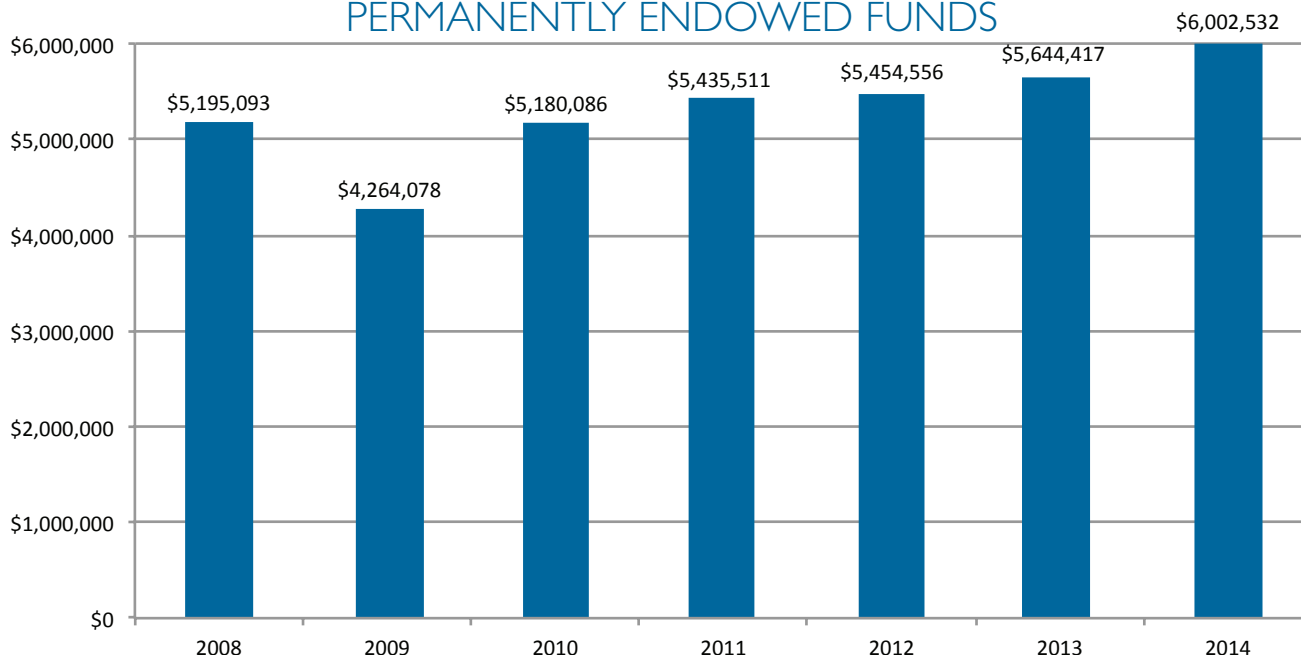

SCHOLARSHIP/TUITION ASSISTANCE PERMANENTLY ENDOWED FUNDS



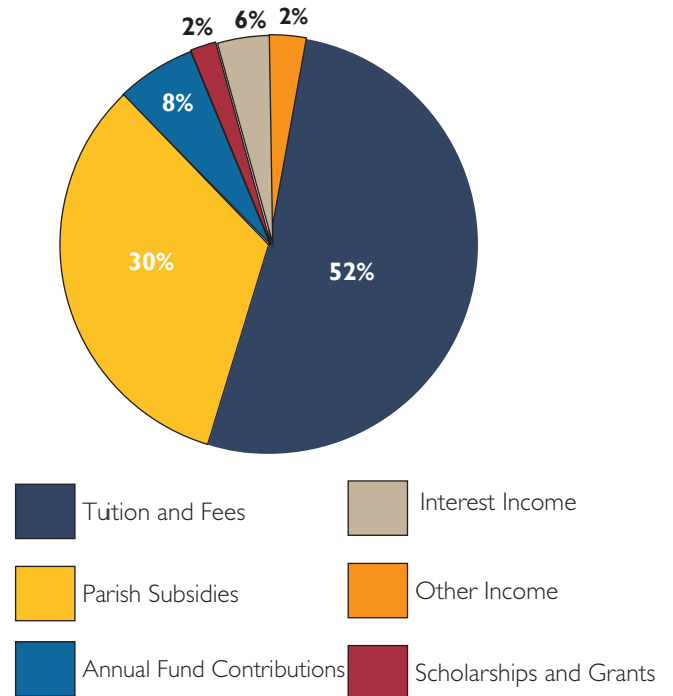

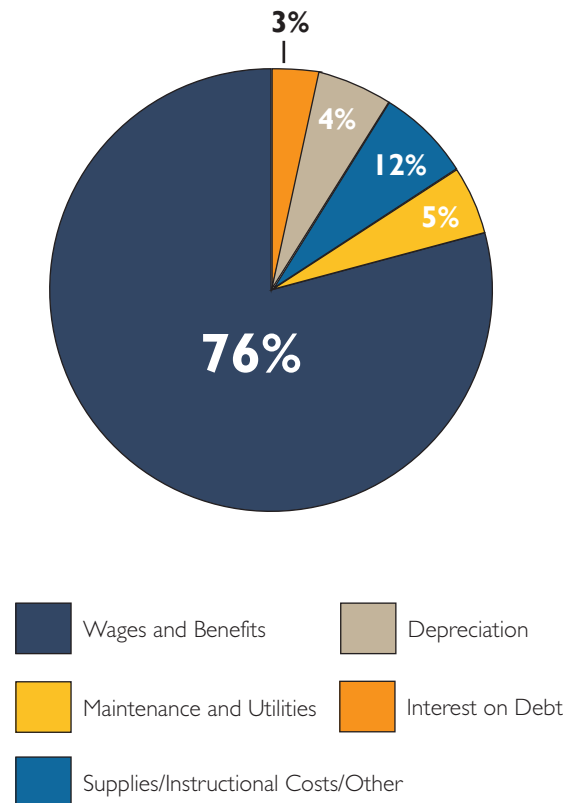

Endowed Scholarships

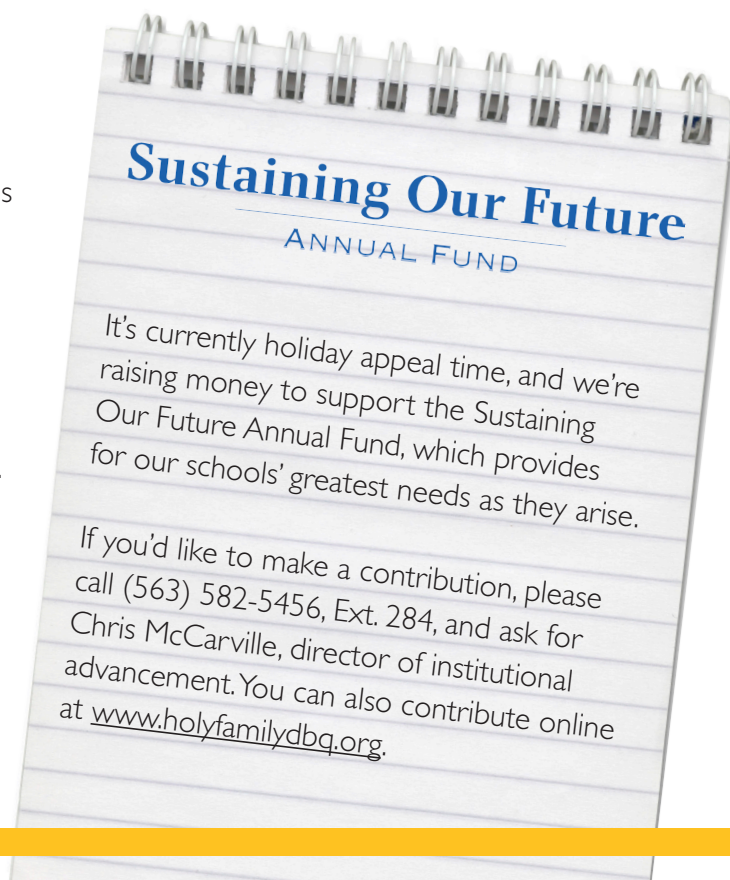
