Dear Friends,

I have just returned to my office after attending Wahlert Catholic High School's Mass of Remembrance. It's a beautiful, moving liturgy that pays tribute to alumni who have died in the past year. As I hear the names of classmates, teachers, friends and other alumni and see their graduation pictures scroll across the screen each year, I am again impressed by, and grateful for, the size and strength of our Holy Family Catholic Schools community.

That size and strength were again on display during the 2012-2013 school year, upon which we report in this document. I encourage you to also visit www.holyfamilydbq.org/familytimes to view the full, online edition of our annual report, an unabridged compilation of our 2012-2013 highlights and a reflection of the hard work and generosity of our staff, students, parents and Catholic community.

The process of assembling this document has given all of us at Holy Family Catholic Schools the opportunity to reflect on all that we have accomplished in the past year. Here are some highlights:

- We have deepened our commitment to ensuring that our students know and are challenged to live their faith through religion classes, opportunities for prayer, celebration of the sacraments, retreats and service. We are especially pleased with our new senior elective course, "Why Am I Catholic," an apologetics course that teaches students how to defend their faith as they move into an increasingly secular world.
- We continue our pursuit of academic excellence by constantly asking ourselves how we can better prepare our students for a future we cannot even imagine. Innovative programming that was implemented last year, such as one-to-one computing for middle and high school students, a pre-engineering curriculum at Mazzuchelli Catholic Middle School and an online supplemental math program at the elementary level, has allowed us to continue to make progress toward our academic goals. We saw the results of our increased emphasis on academics with the Class of 2013 averaging of 24.2 on the ACT, almost two full points above the state mark—and that's with a much higher percentage of the class taking the exam than the state average.
- We have unified the entire system under the crest that had formerly identified Wahlert Catholic. Now the symbol that represents Jesus, Mary and Joseph stands for Holy Family Catholic Schools. Having one mark for our entire system makes our brand much more recognizable in the community.

The success that we experienced last year, and every year, is directly tied to your generous support of our schools. As we continue to work to provide our students with the best possible Catholic education, please know that we are grateful for the many ways that you make Holy Family a better place. We are truly blessed to count you among the members of our large and strong Holy Family Catholic Schools community.

Academic Highlights

Technology Development

Thanks to grants from the Dubuque Racing Association and to the generosity of our Fund-A-Cause donors, Holy Family continued to immerse students in technology. At Wahlert Catholic, science equipment saw an upgrade; at Mazzuchelli, band students used Smart Music to enhance their skills; at Holy Ghost, upgraded wireless access and new laptops helped expand learning opportunities; and at Resurrection, St. Anthony/Our Lady of Guadalupe and St. Columbkille, new iPads allowed younger students to easily access educational applications.

Two Recognized by National Merit

Wahlert Catholic High School students Adam Bradley and Zach Demouly were selected as semifinalists in the 2013 National Merit Scholarship Program.

Wahlert Catholic Senior Earns Perfect ACT Score

Daniel Koch, a member of the Wahlert Catholic High School Class of 2013, earned a perfect score of 36 on the ACT exam.

Ocean Engineering at St. Anthony

St. Anthony Elementary School introduced fifth graders to the field of engineering through an after-school program with an ocean engineering theme. In addition, area engineers were featured as guest speakers to expose students to the different areas and skill sets of engineering.

Wahlert Catholic Named to 2013 Iowa AP Index Top 10

For the second year in a row, Wahlert Catholic High School jumped up the list of Iowa AP Index schools, this time moving to the eighth position. The AP Index measures the average number of AP exams taken by members of the graduating class.

Chinese Added to World Languages

In order to prepare students for life in a global economy, Chinese was approved to be offered beginning in 2013.

Wahlert Catholic Provides New College Resource

With the help of a \$20,000 grant from BP Oil/Molo Petroleum, Wahlert Catholic High School hired David Kelley as college coordinator in August 2012. Kelley assists students with the process of finding the right college or career path. His bi-weekly newsletter provides parents with college search tips and highlights schools that may be unfamiliar to students.

Leading Pre-Engineering Curriculum Comes to Holy Family

Gateway to Technology, the middle school version of Project Lead the Way, was introduced at Mazzuchelli Catholic Middle School. Through this program, students learned to innovate, problem solve and work collaboratively while learning more about careers in science, technology, engineering and math (STEM).

Reading and Walking to Spain

Through a combination of reading and physical exercise, students at St. Anthony and Our Lady of Guadalupe made their way to Spain. For each literacy challenge plus three hours of a wellness or fitness activity, a student earned a footprint worth 8.5 miles. The program started in January and they reached the Azores Islands in March.

Eighth Grade Recognition

On May 30, 2013, 136 members of the Mazzuchelli Catholic Middle School eighth grade class were honored.

Graduation

On Sunday, May 26, 2013, 134 members of the Wahlert Catholic High School Class of 2013 participated in the baccalaureate Mass and graduation. One hundred percent of the class graduated.

Academics

At the start of the 2011–2012 school year, Chief Administrator Carol Trueg challenged every member of the Holy Family faculty to contribute to one goal: help make Holy Family Catholic Schools the top academic system in the state in five years.

Year one meant increased expectations for all students. Teachers were to ask more of their students and to engage them in more rigorous and real-world learning opportunities. Year two, 2012-2013, brought more sophisticated tools to teachers, allowing them to understand what students knew and didn't know in order to guide instruction. Measures of Academic Progress™ (MAP) were administered three times throughout the year with a goal that 65 percent of students would meet their targeted growth (the targeted benchmark is 50 percent). Holy Family students exceeded that goal in math, with 70 percent of students reaching their targeted growth; in reading, 56 percent of students reached their targeted growth.

The Vision: Become the Top Academic System in Iowa in 5 Years

Measuring our Success

Each year, students in grades three through 11 take the Iowa Assessments, formerly known as the Iowa Test of Basic Skills. In 12th grade, students can take the ACT test as an indication of college readiness. Measures of Academic Progress™ tests were also introduced in grades K-11. These standardized tests are one way to measure the success of our academic programs, telling us:

- » How our students are achieving compared to other students in the state and nation.
- » How our curriculum aligns with educational standards.
- » How our students have grown from year to year, and, in the case of our high school seniors, are they ready for college?

Measures of Academic Progress™ (MAP)

Results from the tests helped determine each student's instructional level and predicted annual academic growth. These tests give teachers the data to know what their students are ready to learn. 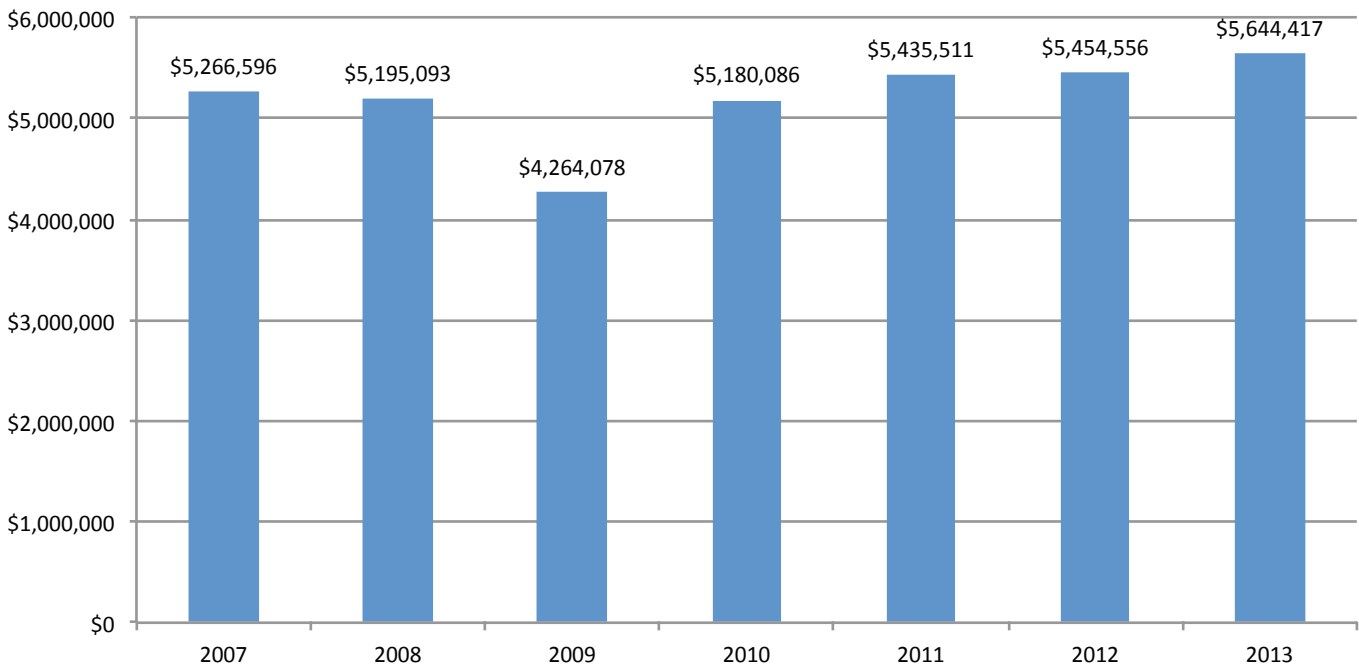

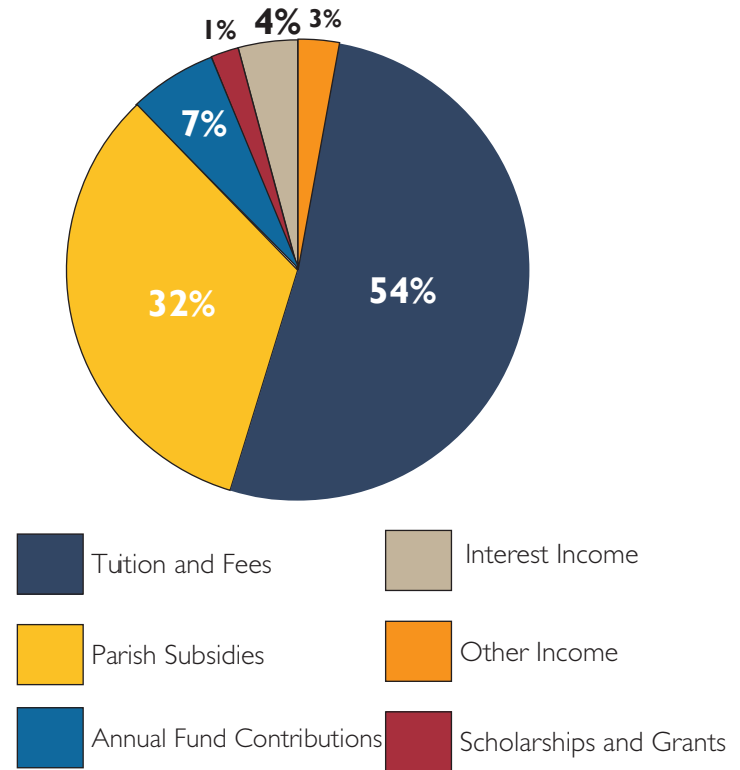

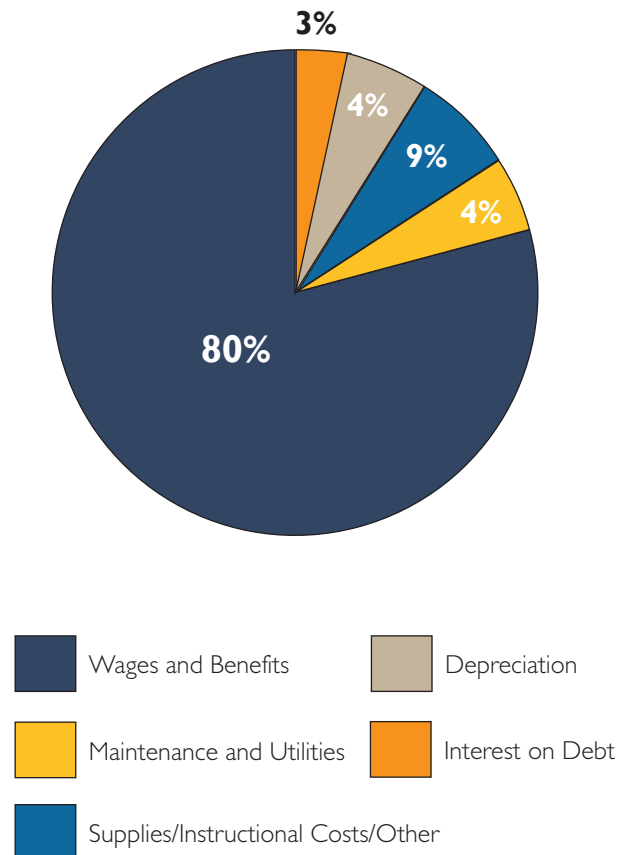

Endowed Scholarships

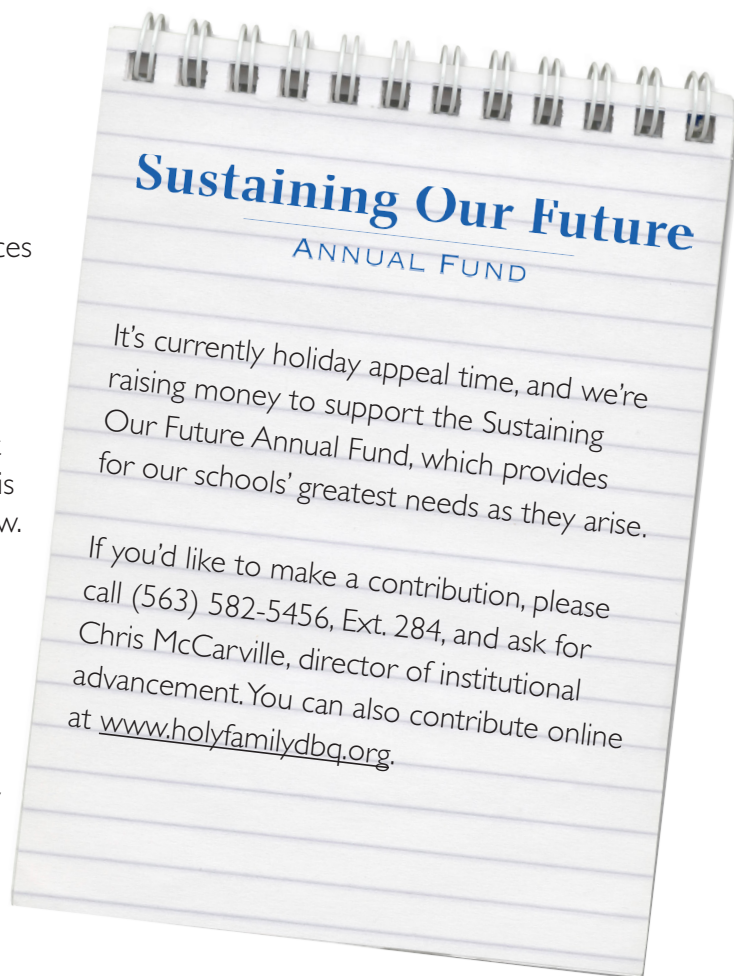
