A Message From the Chief Administrator



Dear friends,

"How has education changed since you began your career?"

That question was one of several a colleague posed to me as part of an interview for an administrative class, and it's the one that I've continued to ponder long after our meeting ended. After all, it seems as though it was just yesterday when I was a rookie high school English teacher, but the truth is I'm starting my 33rd year in Catholic education and my 17th as an administrator.

As I reflect, I realize I have seen a lot of change in that time. Most of it has been for the better, especially since I've come to Holy Family Catholic Schools, where we rely on research-based best practices for enhancing student learning. In addition to the rich new faith experiences we provide in our system, consider these improvements over education from years ago:

Meeting Student Needs: We do a much better job today of meeting student needs in the classroom, whether the student is advanced, needs extra help or falls somewhere in between. Gone are the days when education used a one-size-fits-all approach. Holy Family's teachers do a fabulous job of differentiating instruction, often with our vast technology resources, to provide appropriate challenges to students.

Using Data: Standardized tests such as Iowa Tests of Educational Development used to be something that we administered as required, took a quick look at when they were returned and shelved permanently. In today's education world, our teachers are constantly using that and other data to determine what students are ready to learn and what concepts they may have missed as they plan their instruction.

Creativity is Power: The adage used to be "knowledge is power," with education rewarding students who memorized well. Because information is instantly available today, we work hard to challenge students to create with, evaluate and analyze the information presented. It's a big shift, but one that will better prepare students to make positive contributions to our world.

My list of what is different about today's educational system could go on and on, yet what makes this an exciting profession is that even greater change lies immediately ahead of us as we harness the resources that are increasingly available. With your continued support and our determination to provide the best education possible to our students, I assure you we will continue to be a leader in the field.

TO TRANSFORM WAHLERT CATHOLIC HIGH SCHOOL

Holy Family Catholic Schools is excited to announce that the five-year SOARING Capital Campaign has raised more than \$14 million to renovate Wahlert Catholic High School.

Since the public kickoff of the SOARING Capital Campaign on May 27 when Holy Family celebrated raising \$11.1 million, dozens of volunteers have been working hard to visit with fellow parents, alumni and friends about their support of Catholic education in our community and their investment in our vision for the future. Nearly 400 donors have responded to the challenge to allow us to top the \$14 million mark.

We are tremendously grateful for these extraordinary investments in our future. Early donors to the effort have really set the stage to fully fund the real and urgent need to renovate Wahlert Catholic High School.

While the academic reputation of Wahlert Catholic High School has remained strong for the last 55 years, the building's infrastructure and core academic areas are much the same as they were in 1959. The SOARING Capital Campaign will complete our vision for the future by improving the overall learning environment, our

long-term financial stability and the appearance and functionality of the campus that promotes our Catholic identity.

Holy Family's leadership adopted a phased approach in structuring the campaign goals. Having surpassed the \$10 million Celebration Goal and the \$14 million Challenge Goal, leadership is now focused on reaching the \$17 million Transformational Goal.

TRANSFORMATIONAL GOAL: **\$17 MILLION TOTAL**

Achieving the Transformational Goal will allow us to complete the renovation plan, including:

- Resurfacing the building's siding with brick and block and replacing the roof

- Upgrading the heating system and adding air conditioning
- Upgrading interior electrical service, adding fire sprinklers, modernizing plumbing and removing hazardous materials
- Full-scale renovations to the chapel, classrooms, science labs, restrooms and kitchen
- Improving natural lighting
- Adding a three-story central staircase.

In the coming months, Holy Family will rely on the dedication and financial assistance of our entire community to complete our vision for the future. When contacted about the campaign, please join us! With your continued generosity, Wahlert Catholic High School will continue to soar for decades to come.



ACADEMIC HIGHLIGHTS

MAP: The top academic systems in the country see 65 percent of their students achieve their projected growth each year (above the 50 percent that indicates expected growth). At Holy Family last year, 66 percent of students met their reading growth and 74 percent of students met their math growth. Our adoption of a new math series for grades K-12 this year will help drive further growth.

ACT: With 90 percent of the class of 2015 taking the ACT, the average score was 24, well above the state averages of 67 percent and 22.2 and far exceeding state averages in all college-readiness indicators. Also, 98 percent of last year's seniors achieved or exceeded their predicted ACT scores, our highest number in the years we have tracked this indicator.

AP: Wahlert Catholic was ranked 7th in Iowa on the Belin-Blank 2015 AP Index. Wahlert Catholic is the only Dubuque school to be ranked in the top 10 for the past three years. The AP Index is used to determine the extent of AP opportunities students can access. Advanced Placement programs allow students to pursue college-level studies and take college-level exams while in high school with the possibility of receiving college credit. Wahlert Catholic offers 12 AP courses in biology, chemistry, calculus, U.S. history, government, psychology, world history, English language and composition and English literature and composition. Additional online AP courses are offered as requested. At Wahlert Catholic, 75 percent of seniors are enrolled in at least one college or AP course.

2014–2015 seniors earned a total of 836 COLLEGE CREDITS upon graduation, not including AP credits.

SPANISH COMPETENCY CREDITS:

The state of Iowa recently approved awarding high school competency credit to students who have unique educational experiences that fall outside traditional structures. Students who attended Our Lady of Guadalupe Spanish Immersion School and continued their study of Spanish at Mazzuchelli have the opportunity to earn Spanish credits when they enroll at Wahlert Catholic. Of the 24 students who took a standardized exam, nine earned two years of high school Spanish credit, eight earned three and seven earned four years of credit.

PRESERVING OUR FUTURE

For Wahlert Catholic graduate Chad Huntington ('91), it's about maintaining a "first-class educational system." Current Holy Family parents Craig Takes ('79) and Heather Trees like sending their children to schools with the latest and most up-to-date technology. And although they feel very fortunate to have had four children graduate from Wahlert Catholic, Tim and Elaine Murphy also see the value that Holy Family Catholic Schools provides the city of Dubuque.

Whatever the reason may be, keeping Holy Family's annual fund strong is critical in its quest to become the top academic system in the state.

"While I didn't always recognize it in my youth, my Catholic education was second only to my wonderful parents in shaping me into who I am and what I believe in," Huntington said. "My wife Tammy and I support Holy Family's annual fund because it assists with the operating needs required to maintain the first-class educational system we now enjoy."

Takes and Trees value that Holy

Family is the only school system in Dubuque to give their three children the technology they feel is necessary to succeed in today's world. "Holy Family continues to integrate the latest technology into the classroom, preschool through high school, with the one-to-one (laptop computer) initiative going strong, and Project Lead the Way, FIRST Tech Challenge and FIRST Lego League offering students the latest in STEM education. We are honored to give our time and money to such a dynamic academic and faith-filled environment."

And, with Holy Family Catholic Schools being one of Dubuque's largest employers, former Wahlert Catholic Board of Education president Tim Murphy commented on the importance of Holy Family in the Dubuque community. "We continue to support Holy Family Catholic Schools because a Catholic high school is much needed in the Dubuque community, not only for the existing population. It's needed for future community development

of the business industry and professional community."

When asked if supporting the annual fund while the SOARING capital campaign was in progress was a challenge, Takes and Trees commented, "All of us are being asked to give more than we ever have before to ensure that Wahlert Catholic is a place where today's and tomorrow's students and faculty can thrive." Tim Murphy said, "We are in the midst of the largest capital campaign since Wahlert Catholic was built in 1959. That being said, it's still necessary to support the annual fund."

Quite possibly, however, Huntington summed it up best when asked why donations to the annual fund are now, more than ever, especially important to Holy Family. "This system is a leader in faith, education and community. The system needs leaders to financially support the future of Catholic, faith-based education in our community."







Endowed Scholarships


