

TUITION Assistance

A NAVIGATION GUIDE

1

Circle March 31 on your calendar

In order to maximize your award, you must meet the **March 31 deadline**. Miss that date, and your assistance will likely be decreased.

2

Get familiar with FACTS

3

First time applying?

Application help nights take place on Feb. 21 and March 2 from 6:00-7:30 p.m. in the Holy Family Central Office, 2005 Kane St., Dubuque.

One-on-one help sessions with Holy Family Tuition Coordinator Katie Tracy are also available by appointment on March 8 and 22, 2017, 10 a.m. -6 p.m. Contact: 563-582-5456 x 283 or kttracy@holyfamilydbq.org.

4

Complete your tax return

As soon as you have your W2s, **file your taxes**. This information is critical for your application. If you will not have your taxes filed before March 31, you may use the previous year's return.

5

Submit your application early

FACTS may have questions about your application or need additional documentation. The sooner you complete your application, the more time you'll have to make sure it's right.

6

Apply for scholarships

Eighth-grade scholarship applications for Wahlert are due in early April. **More than \$59,000 is available.**

7

Get your award notification

Your first award report, including STO money, will be sent in the **first week of May**. If you are not STO-eligible but have financial need, Holy Family grants may be awarded in relation to your calculated need.

8

What if it's not enough?

If you have special circumstances making it difficult to pay your entire tuition bill, you may **apply for reconsideration**. This process takes additional factors into account. Parish grants may also be allocated to families that are active in their church. Reconsideration decisions are communicated by July 1.

9

I missed the deadline!

If you miss the March 31 deadline, you still need to complete the FACTS application. We will work as quickly as possible to evaluate and respond to your tuition assistance request.

10

Do I have to apply every year?

Because **circumstances change** from year to year, you must submit the most up-to-date information to assist in the calculation of the tuition assistance you need.

School Tuition Organization (STO)

If you live in Iowa and have a family of four with a household annual income of up to \$72,900, you may qualify for STO assistance. Add or subtract \$12,000 per person for larger or smaller families. **STO awards range from 95% of tuition to \$300 depending on family size and income level.**

4

Not STO qualified?

STO is our largest source of tuition assistance, but if you do not live in Iowa or your income level exceeds STO guidelines, **other forms of assistance are available.**

5

Be an active parishioner

Get to know your pastor and regularly share your time, talent and treasure with your parish. Make weekend Mass attendance a priority and you will be able to access parish grants and credits—and receive countless spiritual gifts as well!

6

Apply for scholarships

Incoming Wahlert Catholic students may apply for a number of scholarships to help with tuition. **The total scholarship money available is \$59,000—and climbing!**

7

Put your child to work

Wahlert Catholic students may participate in a work study program during the summer months to **contribute toward their tuition.** Spots fill up quickly, so don't delay in signing up.

8

Use Scrip and earn rebates

Earn tuition rebates by **buying the items you normally buy.** Dubuque parishes participate in SCRIP, selling gift cards for local businesses and national chains at face value. Because the cards are purchased in bulk at a discounted rate, you earn a rebate that may be used toward tuition. Better yet, enlist your friends and relatives to buy SCRIP, too!

Still not enough? There's another source

Holy Family has budgeted dollars and trust income to supplement tuition assistance from other sources. If **special circumstances exist**, the reconsideration process allows parents to tell their story in consideration of additional assistance.
